WELCOMING SPEECH:

The Chair of the Managing Board - Rector Gulmira Qanay

REPORTER:

Vice-rector for Strategic Development and Social Work Zhanar Rysbekova:

As you know, at the UN Summit on Sustainable Development Goals, the President of the Republic of Kazakhstan Kassym-Jomart Tokayev noted that the UN 2030 Agenda is the only chance given to the current generation to build a prosperous future. Kasym-Jomart Tokayev stressed that for Kazakhstan, achieving the SDGs is a national priority and that the principles of sustainable development have become the basis of the country's national strategies and programmes. At the same time, the Government of the country every two years issues a Voluntary National Review on the implementation of the 2030 Agenda for Sustainable Development.

In addition, at present, our University has intensified its efforts to strengthen its position in international rankings, including those assessing the achievements of universities around the world on the 17 SDGs. Achieving the 17 SDGs makes a huge contribution to eliminating poverty and misery, fighting inequality and injustice, as well as protecting the planet and ensuring peace and prosperity for all people.

In this connection, based on the Protocol of the Meeting "On Participation of the University in the International Times Higher Education Impact Ranking 2024" dated 27.10.2023, the Committee on Sustainable Development of the Company (*hereinafter* - **the Order**) was established by the Order of the Chair of the Managing Board-Rector No. 248 dated 29.12.2023 "On Establishment of the Committee on Sustainable Development of the Company" (*hereinafter* - **the Committee**).

According to paragraph 2 of this Order, the Regulations of the Committee were approved.

According to paragraph 4 of the Order, a page on the University's website on Sustainable Development was opened.

In order to implement paragraph 3 of the Order, the Committee shall:

- Approve the Policy and Plan for the realization of sustainable development of the Company in accordance with the 17 UN Sustainable Development Goals;
- •further on a regular basis to work on effective achievement of the set goals and tasks in accordance with the Plan.
- All Committee members were sent a draft of the Company's Sustainable Development Policy (hereinafter the Policy) in advance for suggestions and additions.

In this regard, today's agenda includes approval of the Policy and other issues on effective achievement of sustainable development.

AGENDA:

- 1) Approval of the Policy;
- 2) Creation of a corner on Sustainable Development and SDGs;
- 3) Launching a course on Sustainable Development and SDGs.

DECISION:

Following the results of the meeting DECIDED:

- 1) Directors of Institutes, *in the form of a responsible person Director of the Institute of Natural Sciences*, to prepare an updated strategy of "Eco Campus KNWTTU", including indicators on greening of the territory, creation of "Green University", introduction of water-saving technologies, waste management and separate collection, energy saving, etc., before the next meeting of the Committee;
- 2) Vice-Rector for Infrastructural Development to create a corner on SDGs in the Conference Room of the Main Building;
- 3) Vice-Rector for Infrastructural Development to allocate an office for the Student Club on Sustainable Development and Eco Life movement;
- 4) Vice-Rector for Academic Affairs to implement an educational programme on Sustainable Development and SDGs;
- 5) Chief of Staff to prepare badges for all Committee members for the next Committee meeting;
- 6) Marketing Department and Department of Digital Technologies to make a video on the importance of Sustainable Development and SDGs with the Board Members.

Following the results of the meeting, it was APPROVED:

- 1. The Company's Sustainable Development Policy, taking **into account the proposals**:
 - to specify ESG footnote;
 - specify all references to the NAPs specified in the Policy;
 - specify the approved Policies of the Company.
