**Course: Russian language in the context of Kazakh intercultural communication**

*Intensity of the course:* 5 academic credits

*Module code:* L-2

*Module name:* Linguistic

*Prerequisites:* Introduction to linguistics

*Purpose:* formation of the master's students' skills of intercultural communication in its linguistic, subject and activity forms, taking into account the stereotypes of thinking and behavior in the cultures of languages in Kazakhstan; to give an idea of the language as a cultural reality; to teach them to navigate the problems of intercultural communication related to the problems of the Russian language as a social phenomenon and communication in Kazakhstan; to give an idea of the languages of modern communications in the context of globalization; to form an idea of the problem of interaction "language-culture-society»; learn to understand the socio-psychological aspects of cross-cultural communication; develop the ability to evaluate and compare the cultural space of two or more languages and analyze culture through the prism of language.

*Short description:* modern linguistics of communication is characterized by the integration of extralinguistic and intralinguistic factors, when awareness of the role of language as a means of accumulation, storage and transfer of knowledge, culture determines the interest in studying and describing the interaction of languages, since intercultural communication begins spiritual communication of people, understanding and cooperation of individuals, and the dialogue of cultures is updated in the communication of individuals.

*Purpose:* formation of professional competencies in the system of linguistic knowledge on cross-cultural communication to ensure language, socio-cultural, cross-cultural, inter-ethnic communication in various fields of professional activity, as well as in the research field; to lay the foundations of communicative competence for future masters in the context of cross-cultural integration.

*Short description:* Course "Intercultural communication" promotes the development of cross-cultural communication skills, familiarization with cross-cultural differences, and the formation of behavioral stereotypes in the modern information space. Intercultural communication is a science that defines the processes of interaction between different cultures and ethnic groups in a multicultural world. The course covers the cultural and anthropological foundations and socio-psychological aspects of intercultural communication, issues of basic categories of culture, features of the practice of intercultural communication and the development of foreign culture.

*Purpose:* to consider the actual problems of modern literary science, to give an idea of the structure and main methodological directions of modern literary studies; to form a conceptual apparatus containing the main fundamental and particular concepts of literary studies as a science.

*Short description:* The Course provides an insight into the transition processes in the methodology of modern literary studies, the dynamics of worldviews as a General cultural process and its regularities; transition processes in modern philological science and their regularities; the main parameters that characterize the traditional scientific paradigm of Russian literary studies; the process of changing methodological attitudes in modern literary studies. The discipline analyzes the most relevant principles of literary works analysis at the present stage of development of the science of literature, as well as touches on the problems of psychology of artistic creativity.

*Learning Outcomes in EP (LOP):*

*Purpose:* to develop the ability to understand and apply modern electronic resources in practice; to demonstrate an understanding of the composition, functions and possibilities of using information technologies; to explain the principles of using information technologies in the process of conducting scientific research in the field of literary studies and folklore; to use technologies for collecting, placing, storing, accumulating, converting and transmitting data in professionally oriented information systems; use various types of software in their professional activities, including special ones; independently develop literary sites and Internet portals.

*Short description:* in the modern world, information resources are becoming an important factor in professional philological activities. The course is designed to form a systematic view of information resources in literary studies; teach them to use them independently.

*Purpose:* training media and information literate teachers.

*Short description:* Information literacy emphasizes the importance of accessing, evaluating, and using information ethically, while media literacy emphasizes the ability to understand the functions of media, evaluate the performance of those functions, and engage rationally with media in the interests of self-expression. The media and information literacy teacher education program combines both approaches. Despite the differences and variations in the conceptual elaboration of media and information literacy learning theories, they are associated with competencies that emphasize the need to develop search skills and the ability to meaningfully interact with media and information channels, regardless of their specific forms and technologies used.

*Prerequisites:* Introduction to linguistics

*Purpose:* teaching undergraduates the basic techniques of critical thinking in teaching Russian language and literature, consider both the theoretical and methodological foundations of critical thinking, and their implementation in the practice of scientific and practical research. During the course, to develop in undergraduates the ability to apply knowledge from the course when analyzing linguistic phenomena; skills of critical discourse analysis; analyze empirical material using methods of critical analysis; provide a critical analysis of linguistic theories; communicative competences as part of its structural components: linguistic, speech, sociolinguistic, sociocultural, strategic.

*Short description:* the discipline “Critical Thinking and Scientific Literacy” occupies an important place in the professional training of masters, which involves the development of a culture of critical thinking, which is due to the complexity of communication processes occurring in the modern information society. Studying the course “Critical Thinking and Scientific Literacy” provides for the active development of critical thinking skills, decision-making techniques, methods of preparing and conducting effective public speaking.

*Module code:* L-2

*Module name:* Linguistic

*Prerequisites:* Russian language in the context of Kazakh intercultural communication

*Purpose:* familiarity with modern approaches to speech communication; deepening and systematizing students' knowledge about the specifics of communicative interaction and speech influence; mastering the skills necessary for the formation of a speech personality in the strategic design of communication and tactical implementation of communication plans in various types of monologue, dialogue and polylogue; development of a general communication culture.

*Short description:* The skills and abilities acquired by students in the process of mastering this course will be in demand when undergoing teaching practice. As a result of studying the academic discipline, the undergraduate must know: methodological and theoretical problems of describing speech influence; components of the communication process and parameters of effective communication activities; cognitive and psychological foundations of speech interaction; linguodidactic foundations of speech planning and control; must be able to: analyze the communicative situation in the cognitive-pragmatic aspect; evaluate the progress and results of speech interaction; determine the effectiveness of tactics, taking into account the addressee factor and varying communication parameters; apply acquired knowledge and mastered operational complexes in new communicative conditions; must be proficient in: communication modeling algorithm; skills of strategic planning of communication activities and tactical implementation of the plan in accordance with the goal; strategies and tactics of information, persuasion, establishing contact and self-presentation; skills in solving communication problems of various types; linguistic means of formalizing your thoughts in various types of communicative situations.

*Short description:* Course "Comparative Linguistics" is aimed at ensuring that undergraduates actively learn basic information on comparative linguistics, basic theoretical works on Slavic linguistics, and obtain professional skills.

*Purpose:* formation of systemic knowledge among undergraduates about the conceptual foundations of communication management as the scientific management of flows of information interaction between people, their groups, public and political formations in order to solve strategic and tactical problems in the development of public relations.

*Short description:* The discipline “Communication Management” is aimed at developing in students an understanding of the theoretical principles, essence, process, functions of communication management, its specifics in various fields of activity and situations. The discipline helps students master the skills of managing information interaction in various fields of subject activity, techniques and methods of conducting communication research for work in relevant departments and providing consulting services.

*Short description:* The discipline “Gender Linguistics” is aimed at studying issues related to the nature of language, its social function, the role of language in the social continuum, the influence of social factors on certain parts of the language system in their evolution and in the performance of functions assigned by society.

*Short description:* the discipline “Transformation of Russian Kazakh prose of the period of Independence” has a practical orientation related to the study of the processes of genre transformation of Russian Kazakh prose; familiarity with the theories of genres and genre transformation; mastering the skills of analyzing the genre transformation of the modernized story by Russian Kazakh authors of the period of Independence.

*Short description:* the discipline “Literatures of the peoples of Kazakhstan: traditional cultural values in the era of globalization” is aimed at understanding the essence of the “Eurasian idea” in the context of the modern literary process of Kazakhstan; formation of artistic and aesthetic perception of national culture and literature among students; role definition.

*Purpose:* Russian culture; developing the ability to compare various cultural phenomena; mastering the specifics of various types of art and understanding the role and originality of literature; familiarizing and assimilating the universal constants of Russian culture; mastering the corpus of texts that most expressively and fully represent the fundamental characteristics of Russian culture; developing the ability to independently understand and analyze individual literary works and the work of writers in a broad historical and cultural context.

*Short description:* the course "Russian literature in the context of world culture" is aimed at developing a broad Outlook in the assessment and interpretation of a work of art, the ability to combine synchronous and diachronic aspects in the analysis of the phenomenon.

*Short description:* Course "Eternal images of world literature" is aimed at further deepening the literary training of undergraduates in Philology, forming ideas about literary directions and schools, mastering practical skills in interpreting texts of works of art, as well as expanding the General humanitarian Outlook.

Linguodidactics as a science integrates knowledge about language with the knowledge of other sciences (physiology, psychology, sociology, etc.) and formulates general patterns of methods for acquiring foreign language knowledge, skills and abilities.

The course of pedagogical rhetoric should cause undergraduates to have a critical understanding of their own speech, to form the ability to eliminate communicative shortcomings in the speech of students.

*Short description:* improving the training of the future teacher-philologist is connected with the need to teach him to use a variety of language tools freely in various communicative and speech conditions, primarily in professional activities, to teach the future specialist the culture of pedagogical communication, to form his skills of accurate and expressive speech. The course "Educational rhetoric", which is closely connected with pedagogy, psychology, ethics and the modern Russian language, plays an important role in the implementation of these tasks.
