3. RESOURCE SUPPLY OF THE EDUCATIONAL PROGRAM 3.1. LIBRARY FUND

One of the important indicators of the quality of personnel training in the educational program is the provision of students with educational, educational-methodical, scientific, reference, fiction and periodicals.

The library fund according to OP 6B01202 - Educator and speech therapist of presuchool organizations as of May 1, 2021 is __62520__ copies, including 48715 copies in the state language, 13805 copies in Russian and _221 copies in foreign languages.

The University Library provides students and teaching staff with access to databases: IPR books, Polpred, Alembook, Web of Science, Elsevier (Scopus).

Access to the Republican Interuniversity Electronic Library (RIELB) was provided, which combines electronic educational and scientific resources of the universities of the Republic of Kazakhstan.

Students of the educational program are provided with access to the following scientific journals: "Defectology in Kazakhstan", "Speech therapist", "Baldyrgan", "Preschool education", "Kindergarten: education and training", "Preschool education", "Management of preschool organizations", "Preschool education" etc.

Since 2010, the library provides an opportunity for students of KazNatsZhenPU to get acquainted with the content of master's theses of the traditional format (more than 150 titles), half of which, today, have been translated into PDF format.

Also, students can use the service "Electronic Library of KazNatsZhenPU", which provides access to the electronic library from a computer from anywhere in the world in 24/7 format (website address: lib.kazmkpu.kz). In the database of the electronic library for the services of students there are about 10,000 units of full-text sources, more than 1,000 units of licensed books, 6,676 units scanned by the library staff, and about 300 units of books belong to the sources of a rare fund.

3.2. TEACHERS STAFFING

The educational program is implemented by the Departments of Preschool and Primary Education and Special and Social Pedagogy. Quantitative and qualitative indicators of the teaching staff serving the educational program (disciplines of the basic and profiling cycles):

The total number of teaching staff is 39 people, including:

Doctors of Science – 1 Candidates of Sciences – 12 Ph.D. Doctors - 4 Masters - 16 The degree of OP is 51.5 %.

The degree of teaching staff of the departments is 51,5 %. The teaching staff are constantly engaged in search activities, apply innovations in the field of preschool education in their experience and actively cooperate with the RSU "Institute of Early Childhood Development" of the Ministry of Education of the Republic of Kazakhstan and a Special and inclusive scientific and practical center in Almaty.

3.3. MATERIAL AND TECHNICAL BASE

The basic training of bachelors of the EP is located in the administrative and educational three-story building located at the address: Almaty, Gogol street, 161. The total area of the educational and laboratory base used for the educational process is 2245.9 sq.m. Special classrooms for the direction of training (209, 210, 211, 301, 304, 305, 306). The educational building is equipped with means of labor and related equipment: desks, tables; there are 5 interactive boards,



TV-video equipment. The educational building fully complies with all the requirements for the organization of the educational process of the direction of training.
