Profile of the Educational Program *Justification:*

The Relevance of the EP. The development of the educational program Fundamentals of law and Economics is due to the fact that in accordance with the updated content of school education in secondary schools, the discipline "Man.Society.Law "is divided into two disciplines "Man and society" and "Fundamentals of law" - grades 9-11, and a new course "Fundamentals of entrepreneurship and business" has been introduced. However, due to the low labor intensity of the disciplines and the relationship between law and Economics, it is important to train teachers who could teach both of these disciplines.

Market Demand. For statistickim data collection "education Statistics of the Republic of Kazakhstan" in 2018, the qualitative and quantitative composition of teachers of history, fundamentals of state and law of public day secondary schools in the Republic of Kazakhstan is only 16707 teachers from 55-59 1398 people older than 59 years 528, the retirement age of 333 people, this suggests that in 5-6 years the need for teachers in the discipline "basics of law" will be 12%, that's not including the course "Fundamentals of entrepreneurship and business." This suggests that in the future, the need for teachers of the Basics of law and Economics will increase.

Coincidence with Similar Results of Leading Universities of Neighbouring and Distant Countries. A study of foreign universities has shown that foreign universities do not train law and Economics teachers for schools, but an analysis of the comparison of educational programs was conducted.

A comparison of the educational program KazNWTTU

- 1) and Cambridge University "Law", "Economics". Undergraduate studies at the University of Cambridge last only 3 years, and the table shows a small number of subjects taught. Also on the official website of the University of Cambridge www.admin.cam.ac.uk/univ/camdata/archive.html a brief description of each educational program of the University is provided, and there is no number of credits of disciplines. Compliance is about 65%.
- 2) and the specialty "Economics and law" of the University of Strathclyde (Scotland), 10 disciplines were found to correspond to the dB and PD cycles, which is about 50%.
