

1. DESCRIPTION OF THE EDUCATIONAL PROGRAM

Objective of the Educational Program:To prepare specialists capable of providing preventive, psychocorrectional, and rehabilitation services to individuals experiencing mental health issues.

1.3. JUSTIFICATION OF THE EDUCATIONAL PROGRAM

The aim of the educational program is to prepare professionals who can provide clinical services based on evidence-based practices, in accordance with ethical and professional standards, for the preservation of individuals' psychological well-being. These professionals should be capable of delivering preventive, psychocorrectional, and rehabilitative services to individuals experiencing psychological problems.



The development and implementation of the joint educational program (hereinafter referred to as JEP) 6V03105 Clinical Psychology, within the field of "Social Sciences," conducted by two Kazakhstani universities - Kazakh National Women's Teacher Training University (hereinafter referred to as KazNUWTU) and S.D. Asfendiyarov Medical University (hereinafter referred to as KazNMU) - with the issuance of a joint diploma, aims to prepare highly qualified clinical psychologists for the preservation of people's psychological well-being.

The social policy regarding the health of the younger generation in the Republic of Kazakhstan is currently based on a medical-psychological model. Clinical psychologists play a key role in working with children and adolescents with weakened nervous systems and psychological health problems. The majority of children are already unhealthy from childhood, with 40% of newborns being born sick or developing illnesses. There is a clear trend of deteriorating psychological health among school-age children. The intensification of the educational process leads to increased overall stress within the general education system. Timely psychological assistance can prevent the disability of this group of children.

At present, according to the data provided by the Department of Medical Care Organization of the Ministry of Health, there are 17 mental health centers in Kazakhstan, with a total capacity of 9,049 beds. The total number of state medical and medical-social institutions for people with mental illnesses is 78. These institutions employ psychiatrists or medical-consultative commissions, including clinical psychologists specializing in the diagnosis, correction, and prevention of mental disorders such as depression, anxiety, bipolar disorder, autism, and others.

The content of the JEP corresponds to the priority areas of state policy in the field of education and public health and aims to implement the project "Quality and Accessible Healthcare for Every Citizen - Healthy Nation" (Government Resolution of the Republic of Kazakhstan dated October 12, 2021, No. 725); Order of the Minister of Health of the Republic of Kazakhstan dated November 30, 2020, No. QR DSM-224/2020 "On Approval of the Standard for Organizing Medical-Social Assistance in the Field of Mental Health to the Population of the Republic of Kazakhstan." It complies with the main principles and provisions of the Bologna Process and the strategic interests of the partner universities' development.

Alignment with similar programs in leading universities in foreign countries

The educational program at Asfendiyarov University takes into account these international standards and aligns with the requirements and expectations of leading universities in both distant and neighboring countries.

1.5. POTENTIAL CAREER PATHS FOR GRADUATES

Graduates of the Bachelor's program in Clinical Psychology are prepared for work in healthcare institutions, educational settings, social-psychological rehabilitation and adaptation centers, psychological correction and psychotherapy centers, scientific, educational, and upbringing organizations, research laboratories in the field of psychology and pedagogy, law enforcement and military organizations, as well as forensic bureaus.

1.6. AREAS OF PROFESSIONAL COMPETENCE (MAXIMUM 3-5 AREAS)

Communicative Competence: Psychologists need to establish and maintain constructive working relationships with their clients, which requires adequate communication skills. This competence is an integral part of all other competences.

Research Competence: Professional psychology programs should include research training to develop students' understanding and respect for the scientific foundations of the discipline. Students should



acquire knowledge of research methods to be informed consumers of scientific knowledge. They should also possess sufficient research skills to develop and conduct projects in professional and, in some cases, academic contexts with the help of specialized consultants (e.g., statisticians).

Expert-Assessment Competence:

Competent professional psychologists rely on various assessment methods to determine which methods are best suited for a given task. Assessment skills can and should be applied to various situations, such as treatment outcomes, program evaluation and development, and issues arising in a wide range of preclinical conditions. This may involve diagnostic classification or identifying strengths and competencies.

Legal Competence:

Clinical psychologists consider and respect current ethical and legal standards of professional practice. They approach cultural diversity sensibly and respect it in their work with clients.

1.7. EDUCATIONAL PROGRAM OUTCOMES

3. RESOURCE SUPPORT FOR THE EDUCATIONAL PROGRAM

One of the key indicators of the quality of training in the educational program is the availability of academic, instructional, scientific, reference, literary, and periodical resources for students. As of May 1, 2023, the library collection for the educational program 6B03103 – Clinical Psychology consists of 22,761 items, including 4,429 items in the state language, 17,754 items in Russian, and 578 items in foreign languages. The University Library provides students and faculty access to databases such as IPR books, Polpred, Alembook, Web of Science, and Elsevier (Scopus). Access to the Republican Interuniversity Electronic Library (RIEL), which consolidates educational and scientific resources from universities across Kazakhstan, is also available. Students of the educational program have access to the following scientific journals: "Questions of Psychology," "Psychology," "Psychological Science and Education," the Bulletin of KazNPU, the Bulletin of Al-Farabi KazNU (Psychology Series), the Scientific and Methodological Journal "Pedagogy and Psychology," and the Scientific Journal of A. Baitursynov Kazakh National University of Women's Pedagogy (Psychology Series). Since 2010, the library has provided students with access to master's theses in traditional formats (over 150 titles), half of which have been converted to PDF format. Additionally, students can use the "Kazakh National Women's Pedagogical University Electronic Library," which provides 24/7 access to the digital library from any location (website: lib.kazmkpu.kz). The electronic library contains approximately 10,000 full-text sources, over 1,000 licensed books, 6,676 scanned items by library staff, and around 300 rare books.

3.2. Staffing The educational program is delivered by the Department of Theoretical and Practical Psychology. The quantitative and qualitative indicators of the teaching staff responsible for the basic and specialized cycle courses of the educational program are as follows: Total teaching staff -17, including:

- Doctors of Science -1
- Candidates of Science -6
- Ph.D. holders -2
