Reliable vs. Unreliable Sources

- Reliable Sources = TRUSTWORTHY SOURCES
- - Written by experts in a particular field.

- Unreliable Sources = SOURCES THAT CAN BE ALTERED BY ANYONE
- Sources, such as Wikipedia, may not be reliable as authors may lack full expertise.



Examples of Reliable Sources

- Examples include:
- Books
- - Newspapers and magazines
- Peer-reviewed journals
- PhD or MBA dissertations and research
- - Public libraries
- - Scholarly articles



Determining Reliability

- Check the URL ending:
- - .edu: Educational institution
- .gov: Government website (often good for statistics and objective reports)
- - .org: Non-profit organization
- For News Sources:
- - Verify focus on information over entertainment
- - Always check the author for credibility



Examples of Unreliable Sources

- Examples include:
- - Wikipedia (for preliminary ideas only)
- Blogs, tweets, and personal websites
- Sites with political or biased agendas
- Self-published and opinionated articles
- Sites ending in .com or .html (potentially unreliable)

Works Cited



- Requirements:
- - Include FIVE citations in MLA format
- Organize entries in alphabetical order
- Use hanging indents for entries that extend past the first line



Formatting Book Entries

- For a book with one author:
- Format:
- Last name, First name. Title of Book. Place of Publication: Publishing Company, year.
- Example:
- Weinburg, Steven. Dreams of a Final Theory. New York: Pantheon, 1992.



Parenthetical Citations

- In-text Citation Example:
- "All logical arguments can be defeated by the simple refusal to reason logically" (Weinburg 25).
- Use citations for any information not originally from you.



Formatting Webpage Entries

- General Webpage:
- Format:
- Title of Page. Date published.
 Organization/Owner. Access Date. <URL>
- Example:
- SpaceTelescope Science Institute Home Page.
 20 Nov 1997. NASA. 28 Oct 2004.
 http://www.stici.edu





- Example:
- "The goal of the Office of Public Outreach is to..." (SpaceTelescope Science).

• Note: Use the first words of the Works Cited entry for clarity in citations.



Formatting Database Articles

- Format:
- Last name, first name. "Article Title." Journal Name. Volume (Year): Pages. Database. Access Date.
- Example:
- Langhamer, Claire. "Love and Courtship in Mid-Twentieth-Century England." Historical Journal. 50.1 (2007): 173-96. ProQuest. Web. 27 May, 2009.
